- The authority of the Organising Committee (OC) to make final decisions;
- Possible sanctions, including expulsion without refund, for serious breaches.

34. **Liability, Cancellation and Refund Policy ***

Liability for Damage and Breach of Rules

Each participant is **fully and personally responsible** for any damage they cause to property, equipment, or facilities during the camp.

In the event of such damage, the participant is **legally obliged to cover the full cost of repair or replacement immediately and in full**.

If the participant refuses to pay voluntarily, the organiser (ikopo, s.r.o – JASPEL) reserves the right to seek compensation through legal means.

If the damage is intentional, caused by gross negligence, or repeated, the participant may face additional disciplinary measures.

Failure to respect the Ethical Guidelines or camp rules may also result in disciplinary action. The Camp Organising Committee (OC) or designated leader has the authority to expel a participant from the camp in cases of serious misconduct.

In the event of expulsion, **the participation fee will not be refunded under any circumstances**.

Cancellation and Refund Policy

In the event that a registered participant is unable to attend the camp after having paid the participation fee, the fee is **non-refundable**.

It is the responsibility of the participant to arrange for another eligible person to take their place at the camp. In such a case, the replacement participant shall pay the participation fee directly to the original participant. The organiser (**ikopo, s.r.o – JASPEL**) must be informed of the replacement and provided with their full name and registration details prior to the start of the camp.

I acknowledge that I am fully responsible for any damage I cause, that I am required to pay the entire cost of repair or replacement without delay, and that camp fees are strictly non-refundable.
